Tournaments Approved / Allotted by MAHARASHTRA BADMINTON ASSOCIATION

It has come to the notice of MAHARASHTRA BADMINTON ASSOCIATION that some companies / clubs / groups conduct badminton tournaments without obtaining permission from MAHARASHTRA BADMINTON ASSOCIATION on commercial basis to make profits.

The Executive Committee of MAHARASHTRA BADMINTON ASSOCIATION decided to impose the following conditions before allotting a Tournament:

- Any Tournament Event Management has to apply through a District or conduct jointly with the District or jointly with MAHARASHTRA BADMINTON ASSOCIATION. Cannot allot directly to the Event Management.
- 10% of the total **tournament revenue** to be given to MAHARASHTRA BADMINTON ASSOCIATION along with the Tournament account duly audited by the Auditors.
 - **Tournament Revenue is**
 - Total Entry Fee collected.
 - Total Sponsorship money received.
 - Advertisement Money.
 - Miscellaneous & Other Receipts.
- 25% of the total amount collected by MAHARASHTRA BADMINTON ASSOCIATION will be given to the District Association under whose jurisdiction the said tournament is organized.

** These conditions apply to all tournaments other than State Selection, State Championships and State Ranking tournaments.

** These conditions apply to all multi district tournaments other than the mentioned above.

** In case of doubts Organizers Must consult the State association directly or through their respective District association.

** Strict action will be taken against players who do not abide by these rules and participate in non-approved tournaments including blocking of their entries from any other State, All India or International tournaments.

** Any tournament organized by affiliated District Association need not obtain any special permission from MBA. Also, in such cases no audit report of the tournaments is required to be submitted by district association to MBA.

** No audit report is required for organization of All India tournaments assigned by BAI.

** The percentage of prize money sharing with MBA is however applicable in such cases as per the tournament guidelines.
