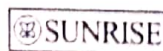
In case of Masters Nationals, the Member Association shall be entitled to following quota of entries for Main Draw

In pair events both players should have Top 8 only. Partnership with points will not be considered.

- Entries Closing Date** :: **1<sup>st</sup> February 2020**  
The Entries shall be received by BAI as per the existing system with a copy to Org. Secretary. The entries are to be received through **Affiliated Units only**. (Direct entries from the Players are not valid). Entries must be send to: **entry@badmintonindia.org**.
- Doubles Entries** :: States forwarding names for Doubles partnering player from different States should have NOC or otherwise names of same pair should come from both the States failing which the entry will not be considered and the entry fee will be forfeited. The respective State units are requested to obtain NOC from other State player before forwarding entry to BAI.
- Entry Fees** :: The entry fees for Qualifying players shall be as follows.  
Singles events of all categories -- Rs. 750/- per player  
Doubles events of all categories-- Rs. 1500/- per pair
- Mode of Competition** :: All matches in Main draw shall be played on best of three games of 21 points in rally point system. However if need be the Referee in consultation with Organising committee and Observer BAI conduct qualifying matches in best of three games of 15 points each with extension upto 21 points.
- Regulations** :: The BAI Competition Regulations and General Competition Regulations shall be applicable.  
In the event of any dispute, the decision of the Tournament Referee will be final.
- Clothing Regulation** :: Players must comply with General Competition Regulations 20 to 24 and will be applicable to the extent applicable.
- M&Q** :: M&Q List based on the BAI ranking list dated on 1<sup>st</sup> February 2020 and published on **10<sup>th</sup> February 2020**  
  
The list of participants in order of strength will be displayed on BAI website. It shall be the responsibility of the affiliated unit and the players to ensure that all the entries forwarded by the Affiliated Units appear in the M & Q (Main & Qualifying) List. After the Last date for withdrawals without penalty, no complaints shall be entertained for omission of any entry. BAI will not be responsible for any omissions of names there after
- Withdrawals** :: **16<sup>th</sup> February 2020**  
  
If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units/ player before the closing date of withdrawal.  
  
Any player failing to participate in any BAI approved tournaments after draw is made, is liable to pay Rs:1500/- each event ( one thousand five hundred ) fine to BAI before participating in next tournament. No exemption under any grounds (including medical) will be allowed in payment of fine. No player is permitted to participate in the next tournament without paying fine.  
  
**Referee shall submit the withdrawal list to BAI within 24 hours after Completion of the tournament to the Secretary (E), BAI.** On receipt of the list Member Associations concerned shall collect the fine amount and forward to the Associations concerned.
- Draw** :: Seeding will decide as per BAI Ranking.  
Draw will be made on **21<sup>st</sup> February 2020**


The President, BAI will nominate one Observer to this ranking tournament.
