Inter Institutional Zone:

Winners of Mixed Team Event is eligible to participate in Senior Nationals Team Championships.

In individual events: Team winners and Runner up are eligible to send 2 Singles, 1 Double and 1 Mixed Doubles in Senior Nationals besides Finalists in all Individual events are eligible for Senior Nationals.

- BAI & BWF eligible ranked players should send their entries through the respective Members Associations before the last date of entries.
- In case of absentees further ranked players are not eligible in their quota.
 - The Host.Association is eligible to participate in this year Team Championships.

SUPER DRAW:

SUPER DRAW Fixtures - Priority to top ranked players.

The procedure for placement of Top ranked players has been as follows.

Men's Singles & Women's Singles

Top 8 players shall be given placement directly to pre quarter finals as per BWF ranked below 50 and BAI ranked players.

Men's Doubles / Women's Doubles & Mixed Doubles

Top 4 ranked players as per BWF below ranked 50 and BAI Top ranking shall be placed directly in to Quarter finals.

Eligibility players:

The list of eligible players shall be released as per the BWF/ BAI ranking as on 20^{th} March 2020

Mixed Team Championship Inter- Zonal Inter State Team Championship shall be played for the following.

NOMINATION OF TEAMS FOR A TIE (TEAM EVENT)

- No player shall play in more than two events.
- Each competing Member Association is responsible for determining the criteria
 and method of selecting players for nomination, and for nominating players, to
 represent its Association.
- 3. Each manager in the managers' meeting shall submit 3 Men singles and 3 Women Singles, 3 Combination of Men, Women, Doubles and 3 Combination of Mixed Doubles in order of team championships. The same ranking order shall be valid for all ties throughout the competition, subject to the maximum players if not more than 5 in each category. For example one player can be nominated in singles / doubles / Mixed Doubles but he or she can play only in two events. For combination purpose a player may be nominated in 3 events but he/she can participate in two events only. Referee is authorized to take the final decision with the consultation of respective manager. In doubles, each team shall play its one pair according to the previously submitted ranking order.
- 4. No substitution of player/pair shall be permitted under any circumstances once the team nominated for the competition.
- 5. Each tie shall be decided by the best of 5 matches as follows.

One Men Singles

One Women Singles

One Men's Doubles

One Women's Doubles

One Mixed Doubles.

- Each manager shall handover the players nomination form to the Referee as
 per the order of merit during managers meeting. (With pair combination). Play
 in each tie shall be stopped when the tie is decided.
- 7. No substitution shall be permitted by the Referee after the draw is completed.
- 8. Play in each tie shall be stopped whenever the tie is decided in 3 matches. It may be 3-0, 3-1 or 3-2 matches.
- 9. If a player withdrawn in singles, he/ she permitted to participate in pair event in the same tie.
- 10. Any change of sequence in order of play in the following tie shall be informed to the Referee in writing before two hours of the commencement of the tie. (1st or 2nd) or Otherwise, the Referee will continue with order of Merit submitted by the Manager during managers meeting before commencement of Tournament.
- 11. The referee shall inform such changes to the opponent team immediately
- 12. Players who withdraws in one tie is permitted to play in the next tie.





 Any player participating in two matches is entitled to a minimum interval of 20 minutes between them.

Entries Closing Date

1st April 2020

The Entries shall be received by BAI as per the existing system with a copy to Org. Secretary. The entries are to be received through Affiliated Units only. (Direct entries from the Players are not valid). Entries must be send to: entry@badmintonindia.org.

Doubles Entries

States forwarding names for Doubles partnering player from different States should have NOC or otherwise names of same pair should come from both the States failing which the entry will not be considered and the entry fee will be forfeited. The respective State units are requested to obtain NOC from other State player before forwarding entry to BAI.

Mode of Competition

: All matches in Main draw shall be played on best of three games of 21 points in rally point system

Regulations

:: The BAI Competition Regulations and General Competition Regulations shall be applicable.
In the event of any dispute, the decision of the Tournament Referee will be final.

Clothing Regulation

Players must comply with General Competition Regulations 20 to 24 and will be applicable to the extent applicable.

M&Q

:: M&Q List based on the BAI ranking list dated on 1st December 2019 and published on 8th April 2020

The list of participants in order of strength will be displayed on BAI website. It shall be the responsibility of the affiliated unit and the players to ensure that all the entries forwarded by the Affiliated Units appear in the M & Q (Main & Qualifying) List. After the Last date for withdrawals without penalty, no complaints shall be entertained for omission of any entry. BAI will not be responsible for any omissions of names thereafter.

Withdrawals

19th April 2020

If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units/ player before the closing date of withdrawal.

Any player failing to participate in any BAI approved tournaments after draw is made, is liable to pay Rs:1500/- for each event (one thousand five hundred) fine to BAI before participating in next tournament. No exemption under any grounds (including medical) will be allowed in payment of fine. No player is permitted to Participate in the next tournament without paying fine.

Referee shall submit the withdrawal list to BAI within 24 hours after Completion of the tournament to the Secretary (E), BAI. On receipt of the list Member Associations concerned shall collect the fine amount and forward to the Associations concerned.

The Secretary (Events), BAI shall be a Convenor.

These members shall be given facilities as specified in Annexure B & C of the

Competition Regulations for attending the Nationals and meetings thereof,

EQUIPMENT SPONSOR:

As per contract of BAI with Yonex, organisers shall be provided with limited

Yonex Shuttlecocks. Additional shuttlecocks shall be purchased by the organiser.

Sponsorship guidelines will be forwarded separately and the same shall be

strictly adhered to by the organiser.

FACILITIES

::

The organizers shall be responsible to provide free hospitality to the participating players, officials from each member Associations to the extent given below.

The Host Affiliated Unit shall provide free lodging and boarding facilities for the tournament days plus one day before only. Lodging shall be provided on the following day of the completion of Tournament upto 12 noon. (No Boarding on the next day).

Every Member Association team taking part in the Nationals shall be responsible for all expenses incurred for their travel and other incidental expenses. Local Transport shall be provided by the organizers as per the timings pasted on the notice board.
