- Mode of Competition** :: All matches in Main & draw shall be played in best of three games of 21 points in rally point system.
- Regulations** :: The BAI Competition Regulations and General Competition Regulations shall be applicable.
In the event of any dispute, the decision of the Tournament Referee will be final.
- Clothing Regulation** :: Players must comply with General Competition Regulations.
- Main Draw list** :: First Main Draw List will be published on **24th November 2024**
The list of participants in order of strength will be displayed on BAI website. It shall be the responsibility of the affiliated units and the players to ensure that all the entries forwarded by the Affiliated Units appear in the Main draw list. If there is any omission, the player/s concerned immediately should contact their State Units and the State Units immediately inform BAI about the omission or proper rectification. After the Last date for withdrawals without penalty, no complaints shall be entertained for omission of any entry. BAI will not be responsible for any omissions of names thereafter.
- Withdrawals** :: **28th November 2024**
If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units before the closing date of withdrawal.

PROTEST :: The fees for lodging protest of any kind shall be Rs. 5000.00 to BAI in prescribed form. Any protest shall be addressed to the Org. Secretary in writing within one hour after completion of the match or 4 hours before commencement of the match. Organizing Secy will forward the complaint and fees to BAI.

TOURNAMENT COMMITTEE :: The President, BAI may nominate Three (3) Members to the Tournament Committee.

4 members shall be nominated by the Host Affiliated Unit.

Hon'ble President, Hon'ble General Secretary and Chairman, TC & Convenor TC, shall be the EX-officio Members of Tournament Committee.

EQUIPMENT SPONSOR: :: As per contractual agreement with Yonex/Sunrise, some agreed number of Shuttlecocks and T Shirts will be provided for the tournament. Additional shuttlecocks, if required shall be purchased by the Organizer. Sponsorship guidelines will be forwarded separately and the same shall be strictly adhered to by the organiser.

FACILITIES :: A.C. single room accommodation will be provided to Referee. For TOs, good A.C. accommodation in twin sharing basis shall have to be provided.

Important Note :: For grooming players from grassroot level, Badminton Association of India have taken the decision of organising U-11 Years Age Group Nationals. However, considering the Mini Age Group of the players, it has been decided that guardians will accompany their players and make their own arrangements for travel, accommodation and Fooding. Host Organisers will keep canteen facilities. However, fooding will be arranged by the Organisers on the basis of purchase of Food Coupons in advance.
