Withdrawals 24<sup>th</sup> September 2024 :: If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units before the closing date of withdrawal. Any player failing to participate in any BAI approved tournaments after draw is made, is liable to pay Rs:1500/- for each event (one thousand five hundred) fine to BAI before participating in next tournament. No exemption under any grounds (including medical) will be allowed in payment of fine. No player will be permitted to Participate in the next tournament without paying fine. Their names will not appear in the M&Q list unless the fine is paid. Referee shall submit the withdrawal list including Referee Report to BAI within 24 hours after Completion of the tournament to the Chairman and Convenor TC. On receipt of the list, it will be circulated to Affiliated Units concerned and the fine amounts thus collected will be forwarded to the Organizers concerned Draw will be made one day before the qualifying draw and one day before Draw :: the main draw at the venue in presence of Organizers/Players and BAI Officials, time of which will be notified by Referee. The President, BAI may nominate one Observer to this ranking tournament. TOURNAMENT :: **OBSERVER** The Chairman Tournament Committee /Convenor TC-BAI will attend the Tournaments / Championships to ensure smooth conduct of the Tournament. **EOUIPMENT** As per contractual agreement with Yonex/Sunrise, some agreed number of :: **SPONSOR:** Shuttlecocks and T Shirts will be provided for the tournament. Additional shuttlecocks, if required, shall be purchased by the Organizer, Sponsorship guidelines will be forwarded separately and the same shall be strictly adhered to by the organiser. FACILITIES •• Organizers are requested to arrange for lunch for Main Draw Players. However, Main Draw Players have to mandatorily collect the Coupons for lunch one day in advance to avoid any wastage. Organizers will arrange lunch according to coupons issued. A.C. single room accommodation will be provided to Referee For TOs, good A C. accommodation in twin sharing basis shall have to be provided. LINE JUDGES ••• Its mandatory to provide line judges from Main Draw onwards. For qualifying draws also, line judges are to be provided -two (2) minimum per court
