RULES, REGULATIONS & GENERAL INFORMATION

(A) ABOUT THE TOURNAMENT

1. Tournament is open to all players registered under the districts of Raigad, Thane, Greater Mumbai, Palghar, Ratnagiri, Sindhudurg and BAMU.
2. As the Tournament is being conducted at the Ramsheth Thakur International Sports Complex, Ulwe, players are responsible for arranging their own transportation.
3. The tournament will commence on Sunday, 11th January 2025 and is scheduled to conclude on Tuesday, 14th January 2025. The duration may be adjusted based on the number of entries received.
4. The tournament will follow the rules and regulations prescribed by the Badminton World Federation (BWF) and the Badminton Association of India (BAI). The decision of the tournament committee will be final and binding on all players.
5. Wearing of badminton gum sole shoes is compulsory and attire must comply with BAI guidelines.

B) ABOUT THE DRAWS:

1. The List of entries received will be published on www.mbasso.in by 7 pm on 8th January 2025.
2. The Draws & fixtures, prepared in accordance with the revised BWF regulations and using tournament software, will be posted on the notice board and made available on the MBA website by 6 pm on 9th January 2025.

(C) HOW THE TOURNAMENT IS GOING TO BE CONDUCTED:

1. **Scoring Format:** The Scoring format will be finalised upon confirmation of the tournament draws.
2. **Line judges:** Line Judges will not be appointed until the Semi-finals. Players may be called upon to serve as line judges, as requested by the tournament officials.
3. **Player reporting:** Each Competitor must report to the Hon. Referee upon arrival at the tournament venue. Any Player failing to appear on court when called by the Hon. Referee, is subject to disqualification.
4. **Dress Code:** Players' attire must comply with the latest regulations issued by the Badminton association of India (BAI). Advertising on the clothing is permitted in accordance with the Badminton World Federation (BWF) rules.
5. **Shuttle cock specifications:** Yonex brand shuttles, approved by the Maharashtra Badminton Association will be used throughout the tournament.
6. **Match Scheduling:** Players must verify their next match details on the notice board before leaving the tournament hall. For any questions or clarifications, players should contact the Hon. Referee, as subsequent complaints will not be entertained.
7. **Identification:** Players must present a valid ID card upon request from the referee.
8. **Venue conduct:** All Players are required to adhere to the club's venue rules and badminton court regulations at all times.
9. Organising Committees decision shall remain final.
