#### RULES & REGULATIONS FOR CONDUCT OF THE TOURNAMENT

- 1. Except as otherwise provided by the Rules by the Tournament Committee, the laws of Badminton Association of India will apply to this Tournament.
- 2. Only registered players Maharashtra shall be allowed to participate in the Tournament.
- 3. For Doubles Events the names of the partners shall be disclosed at the time when entries are given. No entry will be accepted without the name of the partner.
- 4. Entry forms will be accepted only at Vanita Samaj office From 10 a.m. to 7 p.m.
- 5. Online entries are acceptable.
- 6. Yonex Shuttlecocks selected by the Tournament Committee will be used for the matches.
- 7. If the shuttlecock strikes the ceiling or girders during the play, it shall be a fault against the player so striking it.
- 8. The matches will be played, game of 15 point 3 games (with extention) up to pre-quarter finals. All matches from quarter final onwards will be the best of three games of 21 with extention.
- 9. Matches will be played on the Vanita Samaj Court
- 10. Copies of the draw will be placed on the Notice Board of the Vanita Samaj Badminton Hall. A list of each day's matches will also be pasted on the Board. The Competitors are responsible for seeing the Notice Board as to when they are scheduled to play and any competitor, not attending at the time notified, will at the discretion of the Hon. Referee, be liable to be disqualified.
- 11. Play will ordinarily commence at 3.00 p.m. everyday but the Tournament Committee reserves the right to start play earlier than 3.00 p.m. On Saturdays and Sundays matches will start at 9 a.m.
- 12. Competitors who are due to play are required to report to the Hon. Referee Immediately on arrival at the Court on such day and time.
- 13. The Referee shall be the final authority regarding walk-over, which cannot be claimed by any competitor as a matter of right.
- 14. Decision of the Tournament Committee in all Matters connected with the Tournament shall be final.
- 15. Line Judges may not be appointed for the matches till Quarter Finals.
- 16. Players will have to work as Line Judges whenever called for by the Tournament Officials.
- 17. Coloured Clothing: Colour Clothing are allowed as per B.A.I. Rules
- 18. For Junior Events Birth Certificate should be produced when demanded by referee

**Note :** Competitors will not be permitted to compete unless thay pay their Entry Fees.
